Decals may be purchased by mail or by sending a completed application, the appropriate fees and a copy of the vehicle registration (s) and proof(s) of insurance to:

Or, you may complete an application at the gate, pay the fee, receive a receipt and pick the decal up within approximately two business days. Vehicle registration and proof of insurance must be attached to the application at the time of submission. **A copy of your vehicle registration and proof of insurance may be made at the gate for a fee of \$1.00.**

Checks should be made out to the Harbor Island Owners Association (HIOA). Decals are not mailed out. Decals may be picked up at the Security Gatehouse. Vehicle registration and proof of insurance will be checked at the time of issue.

Decals for vehicles that are disabled may be replaced for a short period of time by another vehicle. Contact the Security Supervisor at 843/838-5257, if you have a disabled vehicle. Decals will be replaced free if windshields are broken, the vehicle is replaced, etc. The old decal must be returned for a replacement and must be registered to the same person or company. Decals are valid for one calendar year, January through December.
