

HARBOR ISLAND RULES AND REGULATIONS PARTIAL SUMMARY

We hope you enjoy your visit to Harbor Island. To ensure the safety, welfare and enjoyment of members, guests, renters and visitors, we ask that you look over this brochure outlining the minimum expected standard of care and behavior on the Island. Violations of HIOA Rules and Regulations are subject to monetary fines. This highlights some of the rules and safety issues. Please contact your host or rental agent for a complete list of HIOA Rules and Regulations.

Security personnel and the island manager have the authority to enforce our rules as well as reporting violations to the appropriate Federal, State or County authorities. Refusal to follow instructions from Security personnel may result in significant finest and/or expulsion from Harbor Island.

An adult must accompany children under the age of 15 when using any of the Beach & Racquet Club facilities.

Please read and obey all posted signs.

The speed limit on Harbor Island is 25 mph unless otherwise posted.

If you should become locked out of your residence, you will need to contact your host or rental agent. Please do not call Security.

Entry passes must remain on your dashboard while on Harbor Island. Please read.

Noise that can be heard beyond the perimeter of your property must cease by 11:00pm.

Parking is allowed in driveways and designated parking areas only.

Federal and State laws protect wildlife including, alligators, osprey, sea turtles, wading birds in rookeries, etc. DO NOT feed or disturb wildlife. Lights are not permitted on the beachfront from May through October (turtle nesting). Stay off sand dunes (turtle nesting area).

Please notify Security (843-838-4890) or DNR (800-922-5431) if you see injured wildlife. DO NOT try to capture or move any wildlife.

Dogs must be under the control of a responsible person within the boundary of the unit's property. Dogs must be leashed while on public and/or HIOA common property. Pets must be properly licensed and have the required shots under SC Law.

No person having custody or ownership of a dog or other pet shall allow it to unreasonably bark, whine, howl, screech or growl.

Motorized Vehicles:

Vehicles being operated between dusk and dawn must have operable head and taillights. This includes golf carts.

Drivers of motorized vehicles must possess a valid driver's license or learners permit (operating according to permit restrictions). This includes operating GOLF CARTS. Children may not sit on the lap of an adult and/or steer golf cart.

Motorized scooters, mopeds, ATV's, utility carts, pocket bikes and the like are not permitted on Harbor Island.

RV's, campers (including pop-up) are not permitted on Harbor Island unless approved by the Island Manager.

At no time is parking of trailed boats/personal watercraft and vehicles, allowed on the roadway.

Driving or riding on the beach access boardwalks is prohibited.

Island Enjoyment/Safety:

Fireworks are prohibited.

Unauthorized fires are prohibited (includes beach).

Use of firearms is prohibited.

The condominium and BRC trash dumpsters are for the respective use of those facilities only. Littering is prohibited. Please dispose of trash properly.

Malicious vandalism/or destruction of property is prohibited and may result in criminal prosecution.

Harbor Island has 9 foot tide differentials between low and high tides. We also experience rip tides and undertow. You may be able to walk out to sandbars at low tide, but you can be cut off from the beach very quickly by deep water as the high tide comes in. Use CAUTION.
